

As the world began to experience a pandemic due to the SARS-CoV-2 virus, guidelines and even rules governing the practice of dental hygiene were altered recommending no or limited use of aerosol-generating devices. Dental professionals face increased infection control measures and increased clinical judgement in determining best practices to achieve optimal results, which may include the use of power technology. But is it truly safe to utilize air polishing or ultrasonic devices? This course explores evidence related to the use of power technology while mitigating the risk of disease transmission.
